Normal office hours are Monday through Friday 8:00am to 4:30pm, except Holidays, Federal General Election Day or any closures due to health, weather and/or safety reasons. We encourage online payments at www.rockislandcounty.org (fees apply, an e-check is only \$1.00) Online payments through our website can be set up as "automated" and will include an email reminder prior to payment dates.

1. Reference the 10 digit Property Index Number (**PIN#**) on all checks especially Online Bill Payment through your Financial Institution. Make payable to: Rock Island County Collector. Your canceled check serves as your receipt.
2. Tax stubs must be presented with payment. Homeowners will be charged \$2.00 for a duplicate bill. Mortgage companies will be charged \$5.00 memo bill fee per parcel/payment.
3. Payments can be made at ***some Banks and Credit Unions** in Rock Island County for their customers through the final due date; you must have entire statement including stubs. (*check with financial institution prior to due date) **Mail payments-USPS postmark accepted.** Pay **in Person** or put in the **24 hour drop box** located at the County Office Building address above. **Online payments** can be made at www.rockislandcounty.org or pay by phone through the automated system by calling **1-855-965-4400** (until November 18th, 2022 only) Online and automated phone payment methods accepted are: E-Check, Credit Card or Debit Card. (Processing fees apply)
4. Installments equal to 1/4 of the total tax bill are due on or before the dates shown on this statement. We do not accept partial payments. Taxes paid after November 28th, 2022 must be paid by **cashier's check, money order, or cash**. An additional cost of \$10.00 is added on December 5th, 2022 when delinquent notices are created to publish and mail. **Taxes not paid or postmarked by due date are assessed 1.5% interest per month** effective on the first day following each due date until Paid or Sold at Tax Sale.
5. **Late payments must include interest penalty or your check will be returned.**
6. There is a \$30.00 charge for all "returned" checks from your financial institution. Payment is void if check fails to clear.
7. **If you have sold this property, please forward this bill to the new owner.**
8. If your mortgage company is to pay the bill, it may be indicated in shaded area of stubs or forward a copy to them for payment.

The County Collector only "collects" the taxes for the taxing bodies itemized on the front of this statement. Address questions on assessments or exemptions to your Township Assessor or Chief County Assessment office. Questions on rates and amount of taxes should be addressed to your taxing bodies. Exemptions for Owner Occupied (General Homestead), Senior Citizens and Home Improvement contact your Township Assessor. Exemptions for Disabled persons, all Veterans exemptions, and NDHE (Natural Disaster Homestead Exemption) contact the Chief County Assessment office. Neither failure to receive your tax statement, nor receiving one late will relieve the taxpayer from paying the taxes or any penalties which may become due. 35ILCS 200/ 20-15 A mailing address change cannot be made over the phone. A written request with authorized signature is required! An address change form for tax statement is available in the Collectors office or on our County website, www.rockislandcounty.org
